NATIONAL WOMEN'S HISTORY MONTH

National Women's History Month, observed in the month of March, is in recognition of the many accomplishments made by women throughout history. A variety of agencies, schools, and organizations observe the month by focusing on the "consistently overlooked and undervalued" role of American women in history. Libraries and communities promote special events that emphasize the achievements of women.

The significance of the month of March dates to the mid-19th century when, on March 8, 1857, a group of female garment workers in New York City staged a protest to demand better working conditions and pay. Police aggressively halted the demonstration, but several years later the determined women formed their own union. In 1911, March 19 was observed as International Women's Day (IWD) to acknowledge women's continuing struggle for recognition and rights. The date of IWD was changed to March 8 in 1921. In 1978 the schools of Sonoma county, California, named March Women's History Month as a means of examining women's history, issues, and contributions. The idea gained momentum, and in 1981 a congressional resolution proclaimed the week surrounding March 8 National Women's History Week. In 1986 the National Women's History Project played a significant role in the expansion of the observance to the entire month of March.

We could not let this month pass us by without mentioning the notable contributions that women have made to our democracy. While the list of those names below is by no means exhaustive, it serves to highlight women who have made great contributions to our democracy.



What is a Drug Court, Anyway?

Nearly every American has heard of Drug Courts. While campaigning President Biden has indicated that he would like to expand the availability of Drug Courts. But what are drug courts and how do they differ from regular Court operations such as probation?

Drug Courts are a member of the specialized docket family of courts. Other specialized dockets include Mental Health Courts, Veteran Treatment Courts, and Re-Entry Courts. Specialized dockets throw extra resources at a recurring problem in order to reduce recidivism. The aim of drug courts is to return an individual to health. A person in recovery no longer has to steal and commit other crimes in order to support their dependency. Specialized dockets all involve Judges volunteering to take on extra work to help target a problem issue.

I started Cuyahoga County's first felony-level Drug Court in 2008 with the blessings of my colleagues. Since 2008, Cuyahoga County's Common Pleas Court has added a trauma-based drug court and a medication-assisted treatment Drug Court. We now have three drug courts, each run by a separate Judge. Judge Nancy McDonnell now runs our original drug court. Judge Joan Synenberg runs a trauma-focused court called Recovery Court, and I handle the medication-assisted treatment docket.

When a person enters a drug court, he undergoes a medical assessment using the standard form of the American Society of Addiction Medicine (ASAM). The assessment is a valuable tool performed by trained professionals. It makes a medical diagnosis, calls for the correct level of care, and discusses significant trauma history or other social factors that may help or hinder a person's recovery. The drug court judge and their treatment team follow the recommendations in the assessment.



Most people entering Cuyahoga County's three Drug Courts are severely opiate-dependent and require a residential level of care. Most of our participants get treatment at Community Assessment Treatment Services (C.A.T.S.). We also use Matt Talbot, Stella Maris, The Lantern, The Keating Center, and others.

Upon entering drug court, each participant receives a case manager and a probation officer. The case manager helps the individual work through various life issues that have influenced their dependency. The Public Defender's Office has provided each of our drug courts with a dedicated attorney. All members of the Drug Court Team, including the prosecutor, have the person's return to health as a priority. Drug Court does not look to incarcerate. However, County Jail days are occasionally imposed as a sanction. Studies have shown that outcomes are improved by using incentives or rewards rather than sanctions.

Once an individual in enrolled in a drug court, the Judge sees that individual at least once a month. If the individual is doing well, they're rewarded with a small reduction in court costs. The judge also incorporates some motivational interviewing techniques into those monthly meetings, which are rewards in themselves. Praise from an authority figure goes a long way in keeping people on track.

What does drug court do when someone violates the terms of their participation? First, we look at the violation and ask if it is a violation of a distal or proximal goal. Violations of distal goals are sanctioned less severally than violations of proximal goals. Early on in recovery, showing up at a 12-step meeting is an easy, proximal goal. Relapsing early on in recovery is a violation of a distal goal, staying sober. I may sanction someone to a day in jail for failing to show up for their 12-step meetings early on in Drug Court. I would not issue a jail sanction for someone who was honest about a relapse early on in their recovery.

Most people complete drug court in approximately 15 to 18 months. A few people finish without any violations; however, most people have a bumpier road.

Dependency is a brain disease. It takes a while for one's brain to heal and that is why progress can sometimes be in fits and starts. Drug court is different from regular probation in that the Team really gets to know the individual. This familiarity affords the participant a much greater opportunity for success.

Drug Courts are a wonderful deal for the taxpayer. First, they greatly reduce crime. Of the first 250 people through our Drug Court, only 8% were rearrested within a year compared to 27% in a control group. That rate of crime reduction is simply astonishing. However, the real value in Drug Court is that takes a person in the prime of their life and returns them to the community as a caring parent, a conscientious employee, and a taxpaying citizen. The parents of these participants can go to bed at night without the worry of receiving about their loved one having overdosed.

Our graduates have gone on to do some amazing things, including starting an alumni support group, Project 180. Project 180 sponsors an annual Light Up the Night for Recovery event at Lakewood Park, which is attended by over 500 people. They have monthly events to show those currently in Drug Court that fun is possible in sobriety.

Running Drug Court has been the most fulfilling thing that I have done as a Judge. It's made me a more understanding and tolerant person. It thrills me to be able to take part in the unleashing of human potential.
