Mental Health Fast Facts

May is Mental Health Awareness Month. Please know that if you or a loved one is experiencing mental health challenges, #Youarenotalone. Below are some facts that help to paint a picture of the prevalence of this issue in our nation. We are fortunate to live in a region with excellent mental health care. Do what you can to be a stigma-buster; reluctance to seek help leaves many people suffering many years longer than needed. In fact, the average delay between onset of mental illness symptoms and treatment is 11 years. ~Betsey Kamm

- 20.6% of U.S. adults (51.5 million people) experienced mental illness in 2019, but only 43.8% of them received treatment.
- 5.2% of U.S. adults (13.1 million people) experienced serious mental illness in 2019, but only 65.5% of them received treatment.
- 16.5% of U.S. youth aged 6–17 (7.7 million people) experienced a mental health disorder in 2016, but only 50.6% of them received treatment.
- 50% of all lifetime mental illness begins by age 14, and 75% by age 24.

- Suicide is the 2nd leading cause of death among people aged 10–34 and the 10th leading cause of death overall in the U.S.
- The overall suicide rate in the U.S. has increased by 35% since 1999.

Community Impact

- Lesbian, gay and bisexual youth are 4x more likely to attempt suicide than straight youth.
- Transgender adults are nearly 12x more likely to attempt suicide than the general population.
- 55% of U.S. counties do not have a single practicing psychiatrist.
- 3.8% of U.S. adults experienced both mental illness and a substance use disorder in 2019 (9.5 million people).
- Mental illness and substance use disorders are involved in 1 out of every 8 emergency department visits by a U.S. adult (estimated 12 million visits).
- 20.5% of people experiencing homelessness in the U.S. have a serious mental health condition.
- 37% of adults incarcerated in the state and federal prison system have a diagnosed mental illness.
- 70.4% of youth in the juvenile justice system have a diagnosed mental illness.
- 41% of Veteran's Health Administration patients have a diagnosed mental illness or substance use disorder

Ohio Republicans Bing Resolution to Oppose the For the People Act

On May 6, Ohio House Republicans brought a resolution (HCR 5) to the House floor to formally oppose HR 1, the For the People Act, federal pro-voter legislation that would protect the freedom to vote, prevent billionaires from buying influence in elections, and make sure voting options are equally accessible across all 5 0 states.

It is important to remember what a House Concurrent Resolution (HCR) is as we look at today's vote on HCR 5. An HCR is essentially just an exercise of opinion. It's not legislation, it's the nonbinding, personal view of the

Ohio House of Representatives. What we saw today was the Republicans in the Ohio House saying that voting rights should be eroded, not protected.

The major goals of HR 1 are to expand voting rights, change campaign finance laws to reduce the influence of money in politics, limit partisan gerrymandering and create



new ethics rules for federal officeholders. HR 1 requires that Presidential candidates release their tax returns, just like HB 475, legislation I introduced in the prior General Assembly.

In addition, the For the People Act contain several pro-voter measures already working in states across the country, like same-day registration, automatic voter registration unless the voter opts out, expanded vote by mail, and accessible online voter registration. Ohio Democrats believe these options would deliver safe and accessible elections and include more of us in making our voices heard.

Me and my House Democratic colleagues have introduced a number of pro-voter bills in recent years, including legislation to expand access to secure ballot drop boxes, urge passage of the John Lewis Voting Rights Act, create true automated voter registration, provide voters with paid return postage for mail ballots, and create a safe and accessible online system to request mail ballots, allow more than one early vote center per county and allow ballots postmarked by Election Day to be counted.

In contrast, Republicans across the country have introduced over 350 bills restricting the right to vote this year, including in Ohio, where Republicans have pushed back against pro-voter policies and just recently introduced

House Bill 294, an anti-voter bill that would roll back ballot access and intentionally make the process more confusing for voters.



Common Sense Gun Legislation

The worst thing about the Dayton mass shooting of August 4,

2019 was the human carnage - nine people killed and another 17 wounded. The second worst thing was the State of Ohio has done nothing to prevent that tragedy from happening again. Not one thing.

Last month, Ohio House Democrats renewed their fight for commonsense gun safety legislation that would curb gun violence and save lives in Ohio.

Our call comes amid a spike in gun violence and Ohio's new no duty to retreat bill taking effect in April.

Democrats' commonsense gun safety priorities include legislation that would:

- Require universal background checks on all gun purchases,
- Implement extreme risk protection orders,
- Require safe, secure storage of firearms in homes with minors,
- Allow Ohio citizens to decide what gun safety measures work for their communities,
- Repeal no duty to retreat.

This gun safety package contains tested, proven and popular strategies to reduce gun violence. Some 90 percent of Ohioans support enacting more commonsense gun safety measures.

Me and my fellow Democrats are also fighting to repeal Ohio's no duty to retreat law, which passed in Dec. 2020 and took effect April 6. The law permits the use of deadly force by individuals who believe their lives are endangered anywhere in the state. The measure was added as a last-minute amendment to Senate Bill (SB) 175 in Dec. 2020, and the governor signed the bill into law even after suggesting he would veto the extreme legislation.

We will continue to press Governor DeWine and Statehouse Republicans to Do Something!

Politics Through the Eyes of a Young Person

Many young people aren't interested in politics. Is that because candidates struggle to appeal to these voters? When they try, it doesn't work well. The choice is often between a candidate who isn't interesting and young people find boring, or a candidate who tries way too hard and some young people then find them annoying. America needs someone who's willing to try to appeal to younger voters but doesn't seem

desperate. In a way it could be considered like a first date. Try to be flattering and kind but don't be overly nice, be insincere and there's no second date.

This balance is hard. A charismatic leader is often the one people pick. Even if a candidate's ideas are great, if they are standoffish and cold, or uninteresting and bland, people won't vote for them. Candidates need to preach their messages in a relatable way. If a candidate is someone that working people can relate to, they'll listen. This is how President Biden was elected: appealing to normal voters through voicing his struggles and hard times in the past. Most people have



had hard times, and overcoming them inspires hope for the future.

If a nominee is young and relatable, there is almost no way they could lose the vote of younger people. Another important quality is humility. If someone is humble, this would be the cherry on top of a political candidate. Humble people are likeable and electable.

Finding a candidate with all of these qualities is challenging. It's hard to find someone relatable, charismatic, humble, likeable, energetic that has an interest in political matters. Let's say that one perfect candidate does come up; if they can effectively relay all of that, they can likely count on the young people's vote. There won't have to be excessive trying to appeal to teens and young adults. Appeal is not assumed, it is earned, and relatability is as valued by young voters (and young people who haven't yet voted) as it is in any other group. No candidate should be afraid to speak of their struggles. Many young people are not interested in politics, but that doesn't mean they will always feel that way.


