Ohio's history as a bellwether state is widely known and historically documented. It went with the winner of every presidential election from 1960 until, thankfully, 2020. It is also well known to those of us who live here, Ohio has lost its way over the last decade. It is no longer a good indicator of the nation's political climate. 

Juneteenth, Celebrating Freedom





For many black Americans, Juneteenth is a celebration to commemorate the end of slavery. For many white Americans, recent protests over police brutality have driven their awareness of Juneteenth's significance. Presently, in some states Juneteenth celebrations are week long. The holiday was first celebrated in Texas, where on that date in 1865, (June 19) in the aftermath of the Civil War, enslaved people were declared free under the terms of the 1862 Emancipation Proclamation.

Is Juneteenth a national holiday? It is not yet a federal holiday, but discussions are ongoing throughout the nation. On January 1, 1980, Juneteenth became an official state holiday in Texas. Today, it's recognized in 47 states and the District of Columbia, according to the National Juneteenth Observance Foundation. Hawaii, North Dakota



and South Dakota are the only states without an official recognition.

So many celebrations are being planned in the Cleveland Cuyahoga County area. Here are a few: African American Cultural Gardens (on East Blvd) will have a caravan through the Cultural Gardens (900Am-100Pm). Come walk and enjoy the Gardens.

In April our community hosted a wonderful national showcase event, the NFL draft. Before the draft



those of us who follow the sport were deluged by numerous scouting reports about the best players who might be drafted. These scouting reports included statistics, projections and evaluations by scouting experts about how the player's would best fit in with the team's that might draft them. Some of the scouting reports were objective but most were very subjective.

On November 2 a far more important event will occur in northeast Ohio. That event is an election that will determine who the next mayor of the City of Cleveland is going to be. As we've approached the June 14 filing deadline we've been in what can best be characterized as the "candidate announcement season". The major candidates have all held a press conference to formally announce that they are running for mayor. After these announcements the local media has covered the event's with a scouting report on the candidates capabilities. Included in these scouting reports are positions on various issues, how voters might perceive these positions and prior experience as an elected official and / or in other areas. However, the most important part of each scouting report is always how much money each candidate has raised along with how much more they are likely to raise. The candidates with the large corporate contributions of course are heavily favored over the populist candidates who may have better positions on the issues but don't have the money to get their message out.

Candidates and elected officials often get caught with a particularly bad look corporate contribution that preceded a particularly bad look vote in favor of that corporation's interests. We saw this most recently with the HB 6 scandal and the legislators who voted for the bill after receiving huge contributions from First Energy. Candidates and elected officials often explain these votes by saying that the money they received had nothing to do with how they voted. Really? Then why did they give you that money in the first place?

The term "Fair Elections" is usually used to refer to making sure that everyone who wants to vote can do so as easily as possible. Imagine for a moment that we had completely publicly financed campaigns with all candidates having an equal amount of money to get their message out. Imagine if the scouting reports on



each candidate's capabilities only included the candidates positions on the issues and prior experiences. Imagine if we actually had "Fair Elections".

As Cuyahoga County studies the need for a new County Jail, much attention has been focused on the need for innovative strategies to address jail population. Studies have shown that many inmates in our County

Jail suffer from underlying issues such as drug addiction and/or mental health diagnoses.

Last month, Cuyahoga County opened the first Diversion Center in the State of Ohio. Working collaboratively with law enforcement, addiction specialists, and mental health experts, the Diversion Center will provide treatment options for low-level offenders, rather than simply housing them at our County Jail. This facility, temporarily located on East 55th Street in Cleveland, will provide treatment beds for up to 50 individuals. The residents will receive needed medical assessments, detox services, and connections to other treatment options. Services will be provided



around the clock and outreach to our local law enforcement entities has already begun by the County to assist in identifying which inmates would be ideal candidates for the services provided at the Diversion Center.

This facility will not just reduce the population of our County Jail, but also will address the root issues faced by numerous County inmates.



Mayor Nan Whaley

Nan Whaley grew up in a small town in Indiana and moved to
Ohio to attend the University of Dayton, becoming the first person in her
family to graduate college. She learned the values of hard work,
strength, and resilience from her dad, a union autoworker who lost his



job

but never lost his dignity, and her mom, who went to work at the laundromat behind their house to help make ends meet. She was first elected mayor in 2013 and since then has faced down some of the toughest challenges, including a KKK rally, a series of devastating tornadoes, and a senseless mass shooting that left 9 people dead. Each time, Nan stepped up and led her city through its hardest moments.

Mayor John Cranley



Since taking office in 2013, Mayor Cranley has helped lead Cincinnati's comeback by prioritizing inclusion and investing in people. As Mayor, John oversaw Cincinnati becoming the first city in America to offer two years of high-quality universal preschool and helped lead the doubling of funding for public transportation and infrastructure. Recently, Mayor Cranley broke ground on the largest municipally-led solar project in the country,

which will make Cincinnati carbon neutral by 2022. During his time as mayor, Cincinnati's poverty rate has decreased more than twice as much as any city in Oho.

Before being elected Mayor, John co-founded the Ohio Innocence Project which has helped release nearly three dozen people who have been wrongfully convicted.

Growing up in a family filled with people who dedicated their lives to public service, Mayor John Cranley learned at an early age that putting the needs of others ahead of your own is how you lead a meaningful life. He learned to value social justice and care for those who are in need. Those are the values that John and his wife Dena are passing on to their son Joseph, and those are the values that guide John as mayor.

Congressman Tim Ryan

Tim Ryan is running for the U.S. Senate to cut Ohio workers in on the deal.

A lifelong Ohioan who lives just a few miles from the house where he grew up in Niles, Tim has spent his career fighting for Ohio workers. He's seen in his own community what happens when our politics and our economy aren't working for working people. And he understands that there's nothing more



patriotic than investing in our team, bringing good-paying jobs to Ohio, and making sure our workers can compete with countries around the world — and win.

In Congress, Tim has fought for working families in his district and across the country — opposing unfair trade deals that would ship jobs overseas, pushing to raise wages, and working to protect the promise of a secure retirement by strengthening Medicare and Social Security.

He has taken on the challenges facing Ohio communities, working across the aisle to combat the opioid crisis, and investing in clean water infrastructure for Lake Erie. He's also worked hand-in-hand with businesses to revitalize American manufacturing and bring good-paying jobs and opportunities home to Ohio.

In the Senate, Tim will fight to raise wages, make healthcare more affordable, invest in education, rebuild our public infrastructure, and revitalize manufacturing so we can make things in Ohio again — and he'll make sure we're cutting workers in on the deal every step of the way.


