#### Euclid and the 2020 Census

As we move into Fall it is time to review the impact of the completed 2020 census numbers for the City

of Euclid. The census numbers dictate how our ward boundaries are set. The 2010 census for Euclid was 48,920.

The 2020 census for Euclid, released August 12, 2021 is 49,692, a 772 person increase in our population. Euclid is the 23rd largest city in the state covering 10.63 square miles, and the 861st largest city in the U.S. Our largest age group identified is the population between 18-64 at 61.12%.

As a city we must evaluate and perhaps revise our ward boundaries based on the 2020 census numbers by October 11, 2021. Previously we have worked with the Maxine Goodman Levin College of Urban Affairs at Cleveland State University and the TRIAD Research group to determine, based on current census numbers, the need to

redraw our ward boundaries going forward. Both entities have extensive experience in both redistricting and reapportionment at state and local levels.

This group will calculate the 2020 census populations as it is apportioned to each of the eight wards.

Representatives from the City's administration and from City Council will participate in an initial working meeting with CSU and the TRIAD Research Group to see potential drawing, moving and redrawing of wards boundaries based on the resulting changes in population data using redistricting software.

Drafts of the new ward plan will be presented and reviewed by City Council. Modifications will be made until the revised ward boundary plan is acceptable to City Council. Once the city Council and administration have approved any changes, a informational presentation to the public will be done. The public presentation will include both the process used and the outcomes determined by the 2020 census data.

While this endeavor is not flashy, it is very important to our city going forward. If you have the opportunity, please try to attend scheduled public meetings so you can further understand how and why we may need to revise ward boundaries based on the 2020 census.

#### Ohio and the Texas Abortion Ban

Rep. Kent Smith (D- OH 8)



On Friday, September 3, I released a statement after a controversial <u>Texas law banning abortions after six</u> <u>weeks went into effect</u> on September 1st following a lack of judicial intervention from the Supreme Court. This is the first time a six-week abortion ban has been allowed to go into effect - EVER.

"Overnight, the U.S. Supreme Court denied an emergency request from Texas abortion providers to block the implementation of Texas Senate Bill 8. That Texas legislation went into effect on Wednesday, September 1, and it allows private individuals to sue anyone who provides or assists with prohibited abortions after six weeks of fetal development. It leaves no exceptions for pregnancies resulting from incest or rape. Up until the Court's inaction yesterday morning, it has been routinely ruled this type of state law unconstitutional.

For example, in 1992, the U.S. Supreme Court ruled that states could restrict abortion rights as long as they do not provide an 'undue burden' to women seeking an abortion. In that decision, the court defined an undue burden as a 'substantial obstacle in the path of a woman's fundamental right to choose'. Texas Senate Bill 8 is crafted to create a multitude of undue burdens.

By refusing to stop the anti-abortion measure, the US Supreme Court now poses a real and present danger to reproductive freedom and women's ability to make their own healthcare decisions.

I believe that abortion services should be safe and legal in Ohio. Abortion bans do not end abortions, they only make them far more dangerous for the women seeking them.

However, not all of my General Assembly colleagues agree with my position, and they continue to seek ways to restrict this Constitutional freedom. My fear is that the Supreme Court's inaction to protect a woman's right to make her own health care choices will give a road map to the extreme members of the Ohio General Assembly to further restrict access to abortions and other



medical care that Ohio women want and need. I support a woman's right to make her own medical judgements, and those decisions should not be hindered by Columbus politicians. I believe that Roe v Wade should remain the law of the land," said Rep. Smith.

For your further consideration, these are the anti-abortion bills that have been introduced in the current General Assembly term. I am sure they won't be the last.

In 2019, Gov. Mike DeWine <u>signed the "heartbeat bill" into law</u>. Like the Texas law, this bill would have banned abortions after a fetal heartbeat is detected, which is typically around 6 weeks. A <u>federal judge blocked</u> <u>this law</u> before it went into effect.

good democrats, we fight hard and then come together for the betterment of our party. Together we will succeed!


#### Reflections on the Pandemic

This past year has been like none other. Living through a pandemic is full of experiences and emotions. One could not see with the naked eye the cause for the panic and despair. But as countless people fell ill and unfortunately lost their lives to this invisible, but deadly cause, defenses to combat it and its affects were undertaken rather swiftly. Soon, people were confined in their homes, except for those who had to risk their lives due to their occupation. And sadly, many people lost their lives. However, through it all, resilience, hope, sympathy, empathy, fortitude prevailed. Adjustments were made towards balancing the risks of exposure to the virus and resuming activities, routines, and practices.

While the pandemic was taking a hold in Ohio, I was totally unaware of its seriousness because I was consumed with the March 17, 2020 democratic primary for judge of the Ohio Eighth District Court of Appeals. As I was preparing for the primary election, the campaign came to a screeching halt less than twelve hours



before the election. The election was postponed. Uncertainty of when the election would take place was coupled with how one campaigns when personal contact with voters cannot be had. The Cuyahoga County Board of Elections made an amazing pivot and implemented vote by mail. The April 28 in person voting had all safety protocols in place. My talented campaign managers, Euclid's Brenda Hall, Jerry Primm, and Betty Pinkney, took to the internet, mail, cable and radio to connect with voters.

Through their efforts, the campaign continued and fortunately, I won. The pandemic only paused the election, and the integrity of the election process was preserved.

I not only felt the impact of the pandemic on our election

process, but also on the institution of marriage. Six weeks into the shutdown, I received a request to perform a marriage. That's one of the duties of a municipal judge. A skeleton crew was operating in the court, but visitors were not allowed in the justice center. Willing to perform the wedding, the question of how, had to be answered. Upon review of the law, there was no stated requirement that the marriage official, bride and groom be in the same place. Certainly, we had to see each. So, I had the honor of being the first judge in the county to perform a virtual wedding. As they say, "Love never fails."

A look at the criminal justice system reveals all the many efforts taken to minimize the exposure of the deadly virus to defendants and staff. To start, nonviolent suspects were not arrested, but instead were given summons to appear in court virtually. As the county jail was experiencing a rise in prisoners being infected with the virus, judges began to make decisions who should be released from jail early, without imposing a risk of harm to the community. Defendants were permitted to appear in court remotely. Probationers were permitted to report by phone. Many arrested defendants were released from jail, while awaiting disposition of their cases, with pretrial conditions. In some instances, defendants were released with a GPS ankle monitor. Pretrial notices were texted to remind defendants of their virtual hearing dates. Within a short period of time, criminal reform efforts that had been under consideration were jump started.

As we have begun to more fully manage and navigate our way through the pandemic, a significant question should be answered. That question is, "Do we go back to the way we did things before?" This is a

good question for changes made in response to the pandemic in both our professional and personal lives. For me, I became more serious with my diet. Since, I was cooking more, I ate healthier foods. Being couped up in the house, I cleared up some clutter. Although, I still have clutter to work through. I did more personal reading and formed a book club. Fourthly, I began to walk more frequently. Finally, I kept in touch with family more through countless zoom parties. I am grateful for the positive changes.
