

Cuyahoga County Democratic Party Executive Committee Meeting Wrap Up

The Cuyahoga County Democratic Party Executive Committee met on Wednesday January 26th, 2022, at 6:00 pm via zoom. I am a newly appointed member of this committee and was excited to attend my first meeting. The purpose of the meeting was to review and endorse judicial candidates, Cuyahoga County council candidates, and a candidate for Cuyahoga County Executive, as Armond Budish has chosen not to run for reelection. These endorsements will be used in the May 2022 primary election.



The meeting started a few minutes late as all 671 executive committee members were invited to join the meeting via zoom. This meeting was originally scheduled to be in person, but with the surge of Omicron it was decided that a zoom meeting would be best. County volunteers worked hard

to verify all attendees and the zoom room admitting process went smoothly but did take extra time due to the sheer volume of attendees. At times there were as many as 575 people that had called in some callers having multiple individuals on their call.

County Chair Shontel Brown led the meeting and worked hard to keep the group on topic, organized, and moving through the information and votes as best she could under the circumstances. Brown thanked members for their patience multiple times and politely reminded everyone to remain on mute, the joys of zoom meetings could certainly be felt during these times.

Brown took a few moments during the meeting to announce she would not run for another term as chair of the county party, Vice-chairman Kevin Kelley, resigned days later, and interim Executive Director Helen Sheehan, announced she would also be leaving her role in February. This leaves several key county positions open and could allow for some exciting changes in the future.



During the nearly five hour meeting the executive committee endorsed all unopposed candidates and had three situations where the committee voted, resulting in only two endorsed candidates because in one vote the

candidates were unable to reach the necessary 60% of the vote which officially endorses the candidate. The meeting ended with the County Executive vote, and the only candidate in attendance was Chris Ronayne, who easily won over 92% of the votes and was endorsed.



All said and done the committee and volunteers

worked hard to have a safe organized meeting under the current circumstances. I am hopeful that the next time we meet it can be done in person however I am confident that no matter how we decide to come together all involved will work hard and remain patient during the ever-changing course of this pandemic.



Over the past four years, under my leadership, the Cuyahoga County Democratic Party has engaged voters around the county, even during a pandemic, through Zoom meeting, robocalls, direct outreach and communication and held virtual fundraisers to help support the party. During these past four years we have achieved a significant degree of both financial security and national exposure.

As a Party, we have much to be proud of. This past November, we elected 82% of our endorsed democrats. We facilitated mailing more than 330,000 pieces of literature to targeted democrats or left-leaning voters to push for wins by our endorsed candidates.

We expanded our national outreach and visibility with visits from Vice
President Kamala Harris and Representative James Clyburn. I am committed to
making sure that Ohio remains a purple state in the eyes of the national
democratic leadership because I continue to believe that with strong focus, a
solid plan, and the resources to ensure our plan can become a reality, we can
continue turning out democratic votes in Cuyahoga County and turn our state Blue.



We know that we have our work cut out for us. For perspective, in 2008, there were 1,111,286 registered voters in Cuyahoga County. Today, there are 877,081, a drop of 21%. This means that we have to turn out higher percentages to reach the same number of actual voters. I am happy to report that the Cuyahoga County Democratic Party is doing its part to turn out our people. In 2016, there were 398,276 democratic votes for president. In 2020, that number rose to 416,176, an increase of nearly 18,000 votes. And, we are adding



registered democrats – from 2020 to today, we increased from 187,000 registered dems to now over 222,000. Meanwhile, during my tenure as chair, the Republicans have gone from 16.65% of the overall registered voters to now just 7.5% - a drop of more than half of their members in less than 5 years.

I have been blessed to now be your 11th District Congressional representative - something I work hard at every day to deliver for our community. Because of that role, and because I believe we have the party in excellent shape to continue moving forward, I am announcing that I will not seek another term as Chair of the Cuyahoga County Democratic Party. Thank you to our Vice Chairs, Rudy Stralka, Kim Thomas, Cindy Marx and Troy Greenfield for their support and especially Deputy Treasurer, Vicky Warden and Executive Director Helen Sheehan for moving the Party forward.

Thank you for the opportunity to serve. Thank you for your commitment to our party and our values. We may not all agree on every issue or decision, we know that we are stronger together and we are on the right side of the issues.
